Since 1989, South County Outreach (SCO) has been serving vulnerable Orange County residents in our efforts to realize our vision of a community where no one goes to bed hungry or without a place to call home. SCO assists homeless individuals and families as well as low-income households with emergency services that work in collaboration to address social determinants of health. Annually, SCO assists more than 6,000 residents, 40% of whom are children. 90% of our working-age clients are employed, but they still struggle to support their families. Included in our services are: a free, robust food pantry that distributes 750,000+ pounds of fresh and shelf-stable food annually; homeless prevention services (rental & utility assistance) that is provided to more than 700 households annually; education
